



SOFT PLAY RENTAL CONTRACT

1) The soft play rental equipment has been received by customer in good condition at time of rental and shall be returned to **BusyBee's Playhouse** in the same condition.

2) Customer agrees not to loan, sublet or otherwise depose of soft play equipment or use it at any other location other than agreed address of: _____.

3) Customer agrees to allow **BusyBee's Playhouse** the right to enter premises of customer at designated times at the address above to set-up and repossess said soft play equipment.

4) Customer agrees that it is the responsibility of the person(s) or organization hiring **BusyBee's Playhouse** to ensure that all possible precautions are taken to avoid injury to people or damage to the soft play equipment. Please ensure the following safety instructions are followed:

- **NO** food, drink or chewing gum on or around the soft play area.
- All shoes, jewelry, loose objects, etc. **MUST** be removed before entering the soft play area.
- **NO** face paints, party poppers, colored streamers or SILLY STRING to be used either on or near the soft play area.
- Climbing, hanging or sitting on top of bounce house or climbing, hanging or sitting on safety gates is **not** allowed.
- A responsible Adult **MUST** supervise the soft play equipment, at all times
- Ensure children are not pushing, colliding, fighting or behaving in a manner likely to injure or cause distress to others.
- **NO** pets, toys (other than soft play items) or sharp instruments in the soft play area at any time.
- **NO equipment should be removed** from within play area
- Play areas are designed for **children under _____ years ONLY.**

5) Customer agrees to pay a \$50.00 deposit at the time of rental and pay in full, the cost of the rental before or at delivery. Rental will not be set up until full payment is received.

6) Customer agrees to pay in full the replacement cost, including labor, for all damages to soft play equipment.

7) If the soft play equipment is lost, stolen, or damaged beyond repair, the renter agrees to pay up to \$3000.00 in replacement costs.

8) Customer agrees to ensure that all users (and users' guardians) of the rental read and comply with all rules.

9) Lessee understands and acknowledges that soft play entails both known and unknown risks including, but not limited to, physical injury from falling, slipping, crashing or colliding, emotional injury, paralysis, distress, damage or death to any participant.

10) THERE ARE NO WARRANTIES OF MERCHANTABILITY OR FITNESS EITHER EXPRESSED OR IMPLIED. The person(s) or organization renting this Soft Play Equipment from **BusyBee's Playhouse** will be held responsible and liable for any and all damage or injury occurring for any reason whatsoever.

I have read the above agreement and fully understand and accept the conditions as above. I am aware that while in my care I am fully responsible for the soft play equipment and will pay for any loss or damages that may occur. Lessee agrees to indemnify and hold **BusyBee's Playhouse** harmless from any and all claims, actions, suits, proceedings, costs, expenses, fees, damages and liabilities, including, but not limited to, reasonable attorney's fees and costs, arising by reason of injury, damage, or death to persons or property, in connection with or resulting from the use of the leased equipment. This includes, but is not limited to, the manufacture, selection, delivery, possession, use, operation, or return of the equipment. Lessee hereby releases and holds harmless **BusyBee's Playhouse** from injuries or damages incurred as a result of the use of the soft play equipment. **BusyBee's Playhouse** cannot, under any circumstances, be held liable for injuries as a result of inappropriate use, God, nature, or other conditions beyond its control or knowledge. Lessee also agrees to indemnify and hold harmless **BusyBee's Playhouse** from any loss, damage, theft or destruction of the soft play equipment during the term of the rental and any extensions thereof.
